### **JOB SUMMARY:**

The Materials Planner and Scheduler is responsible for converting multiple inputs into a cohesive plan for the high level scheduling of manufacturing and generation of a materials requirement plan, producing supply chain forecasts and ensuring inventory procurement meets Production shipment schedules, while maintaining the minimum inventory exposure.

The person will be required to utilise inputs from the Sales Team, R&D and Product Management, considering both contract manufacturer and 4RF on-site production capabilities to ensure sufficient material availability to meet company requirements.

This role will also be required to perform additional tasks such as monitoring and reporting on contract manufacturer's performance and supporting R&D component sourcing and procurement for prototype designs.

# Procurement and Inventory

- Facilitate monthly reviews prior to release of major sub assembly purchase orders from contract manufacturers involving Sales, Finance and Supply Chain personnel
- Identify, socialise and execute potential cost savings across all product lines
- Negotiating last time buys and bulk purchase agreements with key component suppliers
- In conjunction with Production and R&D develop strategies for inventory reduction and phase out of obsolete inventory
- Facilitating stock accuracy via cycle counts in conjunction with the warehouse manager
- When required raise purchase orders ensuring timely placement and subsequent delivery of sub assemblies and individual line items

## Reporting and Monitoring

- Regular monitoring of contract manufacturer and key supplier performance, review historical data, material on time delivery and incorporate quality information to identify significant variances against requirements
- Report on contract manufacturer and key supplier performance, trends and variances both internally and to the external supply chain
- Responsible for inventory management, accuracy and reporting in conjunction with the warehouse manager
- Liaise with Finance to ensure company financial inventory value and projection models are accurate and reflect the anticipated shipment and procurement plans
